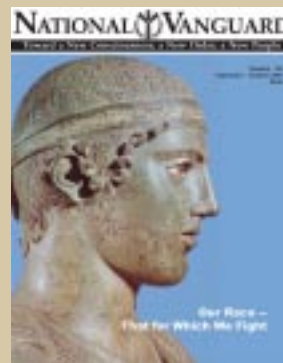

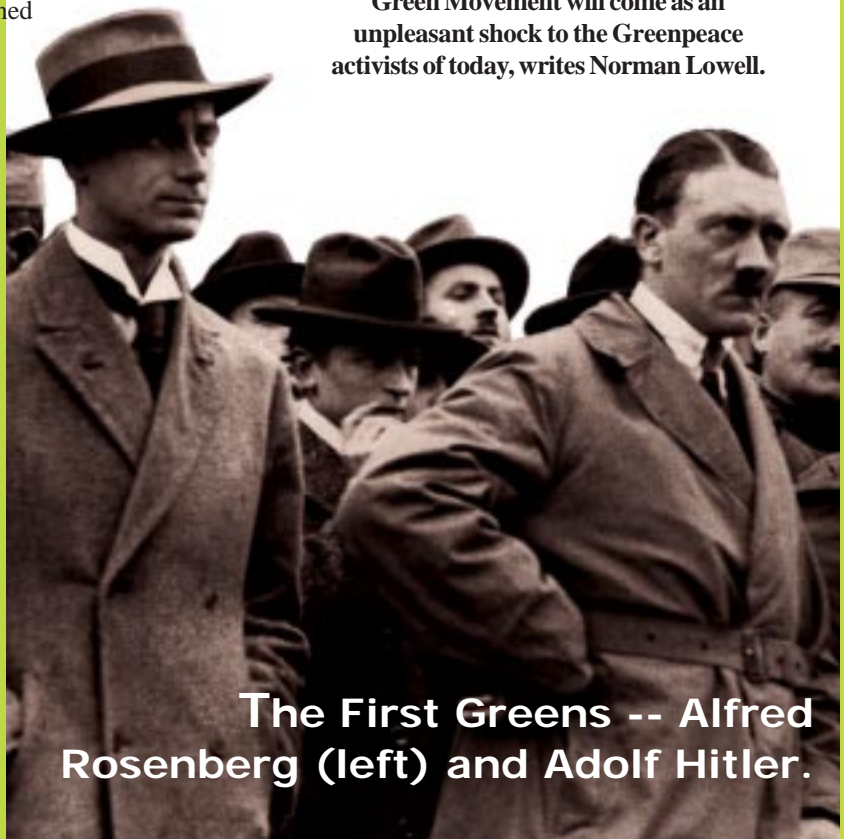

# Racial Preservation is Green

**The National Socialist Origins of the Green Movement will come as an unpleasant shock to the Greenpeace activists of today, writes Norman Lowell.**

Although a long believer in the cause, and one of the few who understood that all of his previous activities – striking at the enemy in the heart of the nest which made up the ruling elite of Washington DC and environs, the encrypted signal received by the Eastern Seaboard command was exciting in the extreme: it ordered the immediate evacuation of the entire armed unit of the White Liberation Army to the Midwest, where the senior command had managed to seize a territory from the Montana National Guard.

“This is the play of the game which will determine whether we are going to succeed or not,” Stanton said to his second-in-command as they digested the news. “We will now come out into the open, and the battle will be taken face to face.” Both men knew the implications: the time of the guerilla war they have been waging till now was coming to an end. Without territory, without an operating base, and without the ability to stake their claim openly and draw upon a large recruiting base, they would slowly but surely fizzle out as the war of attrition with the state slowly depleted their ranks.
